

Schedule of electricity standard variable rates for non-domestic customers

These charges have been set out by British Gas Trading Limited. If your terms and conditions are for small businesses, our standard variable rates apply only in exceptional circumstances. If you choose not to agree a new energy plan with us when your current plan ends, you'll automatically move to our variable price plan instead of our standard variable rates.

If your terms and conditions are for large and corporate businesses, the standard variable rates published in this document will apply where a fixed-term contract has ended but you have not left our supply and have not agreed a new contract with us.

From 1st April 2024, all electricity supplies which this schedule applies to will be charged in accordance with the rates set out below. Our standard variable rate may be higher than our contract prices so please contact us to see if we can offer you a better price.

These charges are subject to withdrawal and can be changed with 30 days' written notice.

Rates for non-half-hourly sites and half-hourly sites with whole current meters

The charges for non-half-hourly settled sites and half-hourly settled sites with whole current meters are based on banded pricing depending on the profile class as shown in the following table and apply to all areas supplied by us. All prices are excluding VAT, which will be charged at the prevailing rate applicable to your business, and Climate Change Levy (CCL).

Half-hourly rates

Half-hourly settled electricity sites will be charged as shown in the tables overleaf (excluding whole current metered sites). The charges relate to each premises supplied under the scheme. All prices shown exclude VAT, CCL and other applicable indirect taxes, each of which will be charged at the prevailing rate applicable to your business. There may also be charges for excess reactive power and excess capacity.

Targeted Charging Review (TCR)

[^] Capacity charge: Cost charged by your local Distribution Network Operator (DNO). The rate applies as a pence/kVA/day rate, where the kVA refers to the Maximum Import Capacity you've agreed with your DNO. An excess capacity charge will be applied if you exceed your agreed supply capacity. These charges are applied by your DNO and are passed on to you through your bill. Please be advised you can contact your DNO at any time to check your agreed supply capacity and also speak to them if there is a change in your business energy requirements.
